DESCRIPTION

Enviro Agi Clean is a concentrated, environmentally friendly cleaner which is non-corrosive to the skin and most metal materials.

RECOMMENDED USES

When diluted with water, Enviro Agi Clean can be used to effectively and efficiently clean cement dust and concrete residue from vehicles and machinery (concrete agitators, concrete pumps, level screeders) used within the pre-mix concrete industry.

PACKAGING

Enviro Agi Clean is available in 20 and 200 litre drums, as well as 1000 litre palecons.

DOSAGE RATE

For best results dilute the product with water at the rate of approximately 1 part Enviro Agi Clean to 2 or 3 parts water (1:2 or 1:3).

Note: Enviro Agi Clean can be used at 100% concentration in specific applications. Please contact to your ACS Area Manager for further advice.

MIXING AND APPLICATION

Apply diluted Enviro Agi Clean to the affected surface using a broom. Rinse thoroughly with water prior to surface drying.

IMPACT ON BASE MATERIALS

When diluted as per recommendations, Enviro Agi Clean is safe to use on most good quality paints and plastics.

The product will have very little affect on stainless steel, steel, bronze, copper and brass.

When applied to aluminium or zinc surfaces Enviro Agi Clean is more aggressive and may show some signs of affect after prolonged use.

CLEANING

Ensure all application tools are cleaned with water both before and after use.

STORAGE

If stored in its original container, and at temperatures between 5°C and 30°C, the product will keep for up to twelve months.

HEALTH AND SAFETY

During use, avoid inhalation of dust and contact with the skin and eyes. Wear suitable clothing, gloves, eye protection and respiratory protective equipment.

If contact with the skin occurs, thoroughly clean the area with plenty of fresh water and soap. In case of contact with the eyes rinse with plenty of fresh water and seek medical advice.
